- Place:** Alhonna Resort, State Road HH to 1237 Outer Drive, 573-365-2634. Please call now for room reservations and boat rental. For directions visit [www.alhonna.com](http://www.alhonna.com).
- Times:** Boat inspection 5:30 a.m., Start 6:30 a.m., Finish 3:30 p.m.
- Entry Fee:** \$75.00 per man, \$150.00 per boat. Fee includes Big Fish Pool. Money must be in by **April 22, 2020**. No late entries will be accepted. Please enter early, boat numbers will be issued in the order we receive entry fees.
- Rules:** The following rules will be used. These rules will be administrated by the tournament committee. All decisions by the committee will be final. *Polygraph tests may be required.*
- Tackle:** All fish must be caught on Rod & Reel. Only artificial baits are permitted. Only one (1) rod may be used at any given time.
- Safety:** *Safety is paramount.* All contestants must wear a U.S.C.G. approved life jacket any time the gas motor is running.
- Boats:** All boats must have an aerated live well or cooler. No boat can be transported during the tournament.
- Permitted Locations:** No fishing point to point PB2 Cove. No fishing within 50 yards of another contestants boat.  
**NO fishing at Alhonna Resort Docks**
- Scoring:** Only legal fifteen inch (15") Kentucky, Small Mouth or Largemouth Bass will be counted. Total stringer per boat will be five (5) fish. Any short fish will be put back in lake immediately plus 1- pound penalty from total stringer weight. Deduct 1/4 pound for dead fish. Do not bring frozen or mangled fish to check-in; you will be disqualified along with your partner.
- Ties:** Number of legal fish weighed, largest bass, then flip of coin if needed will break ties.
- Pre-Meeting:** Alhonna Resort, Friday, April 24, 2020, 7:00 p.m. Tournament rules will be reviewed at this time. Attendance prizes will be given ut. Please make an effort to attend.
- Payback:** 75% of money collected will go towards purse. 25% for food, beer, attendance prizes & misc costs
- Big Fish Payback:** Payment is as follows: 1st Place: \$350.00,
- Closing:** You must know these tournament rules. Failure to read or understand these rules is no excuse. Protest will be submitted in writing to the tournament director within 15 minutes of the end of the weigh in.



We have provided the following directions to assist you in driving to Alhonna Resort. We suggest you bring a road map if you are not familiar with getting to Lake of the Ozarks.

*Driving Directions from Kansas City:*

**I-70 East to Highway 63 South in Columbia. Proceed on 63 South to Highway 54 West at Jefferson City. Follow Highway 54 West to Business Highway 54 also marked “Bagnell Dam”, exit to your right. Follow “Directions For All” below.**

*Driving Directions from St. Louis:*

**I-70 West to Highway 54 West at Kingdom City. Proceed on Highway 54 West to Business Highway 54, also marked “Bagnell Dam”, exit to your right. (Note: DO NOT EXIT ONTO BUSINESS 54 IN FULTON) Follow “Directions For All” below.**

*Driving Directions from Columbia:*

**Highway 63 South to Highway 54 West at Jefferson City. Proceed on Highway 54 West to Business Highway 54, also marked “Bagnell Dam”, exit to your right. Follow “Directions For All” below.**

*Driving Directions from Springfield, Mo:*

**I-44 East to Highway 5 North in Lebanon. Proceed on Highway 5 through Lebanon to Camdenton. In Camdenton, turn right onto Highway 54 East at the stoplight. Follow Highway 54 East through Osage Beach. Exit to your left at Business Highway 54. Follow “Directions For All” below.**

*Directions for All:*

**At the first stop light, on Business Highway 54, turn onto Horseshoe Bend Parkway, coming from Bagnell Dam you will turn right, coming from Osage Beach, you will turn left. Follow Horseshoe Bend Parkway to Outer Drive (approximately 7 miles). Follow Outer Drive to Alhonna Resort. [www.alhonna.com](http://www.alhonna.com)**
